All participants must sign two "Assumption of Risks, Release & Guarantee" documents included in the Registration Procedure: one for Drukpa Publications Pvt. Ltd. and the other for the logistic organizer Wilderness Experience Travels Pvt. Ltd.

In consideration for Wilderness Experience Travels Pvt. Ltd. allowing my participation in the event for which I am registering, I freely agree to and make the following contractual statements and agreements:

Risks of Trekking

I understand that participating in the trekking tour offered by Wilderness Experience Travels Pvt. Ltd. for which I am registering is a potentially hazardous activity. I fully realize and appreciate the dangers of trekking and rafting (if circumstances arise) and fully assume the risks associated with this activity. I understand that trekking in less developed and remote areas of Maharashtra, India, significantly increases the danger of trekking. I fully accept and assume all risks including, by way of example but without limitation, physical injury, mental injury, the dangers arising from potential animal attacks such as dog bites, surface hazards, equipment failure, inadequate safety equipment, the effect of weather, including extreme temperature or conditions, traffic, the condition of the road, lack of adequate traffic laws, and participating in event along the route. I understand that potentially dangerous situations which are beyond the control of Wilderness Experience Travels Pvt. Ltd. may arise during the tour. I assume the risks of all dangerous conditions during the Wilderness Experience Travels Pvt. Ltd. event and waive any and all specific notice of the existence of such conditions.

Knowing the risks involved, I agree to assume those risks, and to release Wilderness Experience Travels Pvt. Ltd. and its employees, agents, affiliates and officers, including but not limited to Drukpa Publications Pvt. Ltd. and Drukpa Publications Pvt. Ltd.'s affiliates, subsidiaries, employees, volunteers, agents, officers, directors or students (the "Parties") for any and all damages, including but not limited property damages, illness, injury or death that may occur in travel to and from these tours, even if such damages arises out of the intentional act(s) or reckless negligence of the Parties. I agree to have adequate medical insurance including evacuation insurance coverage for the duration of Wilderness Experience Travels Pvt. Ltd. event. If I am incapacitated, I give my consent to allow emergency medical treatment for my injuries and/or medical evacuation if necessary. I acknowledge that Wilderness Experience Travels Pvt. Ltd. does not guarantee the reliability or safety of suppliers of services to tours. I also understand that Wilderness Experience Travels Pvt. Ltd. makes no explicit guarantee for my safety or protection while on tour. I will assume and pay all medical and emergency expenses incurred by me in the event of illness, accident, or other incapacity regardless of whether I have authorized such expenses.

Participant's Responsibility

I understand that I will be trekking at my own risk and I will not participate unless I have been properly trained, physically and mentally able to do so. I acknowledge, represent and warrant that I have no physical or medical condition which to my knowledge would endanger myself or others if I participate in this tour which may

Ltd.'s affiliates, subsidiaries, employees, volunteers, agents, officers, directors or students (the "Parties") from liabilities for any and all damages including but not limited, injury, or death, which may occur to me or anyone else, even if such damages arises out of the intentional act(s) or reckless negligence of the Parties.

I agree to abide by all rules established by Wilderness Experience Travels Pvt. Ltd., to conduct myself in a safe and respectful manner at all times and respect the rights and privacy of other trip members. I understand that if I leave prior to the daily starting time or walk on a different route than described, that I will not be able to receive all the services described in advertisements or other literature. Ltd. reserves the right to refuse service to anyone at any time prior to or during the trip, if in Wilderness Experience Travels Pvt. Ltd. sole opinion, an individual's physical condition or behavior is incompatible with the enjoyment of the group as a whole. I also acknowledge that Wilderness Experience Travels Pvt. Ltd. and the Parties will not be responsible for any lost or stolen equipment, luggage, money or personal items at any time during the tour.

I acknowledge that since I have freely chosen to participate in a trekking tour in India, that I may not receive the same level of government services or protection in India as I would in my home country and that travel in less developed regions in India may entail risks greater than those in my home country.

Wilderness Experience Travels Pvt. Ltd. and the Parties are not responsible for refunding airline fees due to change in itinerary or tour cancellation or theft of any personal gear. I also give my permission for use of my name, photograph, motion picture, recordings and evaluations by Drukpa Publications Pvt. Ltd. and Wilderness Experience Travels Pvt. Ltd. for promotional materials. All information provided by Wilderness Experience Travels Pvt. Ltd. including but not limited to route maps, instructions, directions is privileged information and all contents are copyrighted. Reproduction is by permission only.

I agree that if any part of this Wilderness Experience Travels Pvt. Ltd. Liability Release, Assumption of Risks, and Responsibilities Agreement is found to be void or unenforceable, then only that section will be stricken but the rest will remain in effect. I agree that if I or my successors sue or assert any claim against this agreement, I or my successors shall be liable for the expenses, including legal fees incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable or such claim for willful and wanton negligence.
